#### Junior Development

The GV Devils, after their success in Warrnambool in January, are heading off to Bendigo for the under 18 State Championships. They have entries in most of the competitions there, and we wish them a great outcome.

The tournament to be held at Stanhope to raise some funds for the Championships was called off due to low numbers. This was disappointing, and probably due to several other events being held around the same time. It is planned to hold the event later in the year.

It is extremely pleasing to see that some of these juniors are playing Pennant in the higher divisions and holding their own.

#### **Webmaster**

The website is proving popular, with over 500 visitors on a Tuesday and around 700 on Saturdays. In the last month 78% were returning visitors/users with more than half of all visitors using a mobile device to view the website. It is expected that usage will drop as competitions become dormant over the winter months.

BOWLSLINK results reporting went well this year. I managed with the assistance of the Match Committees to get most of the State events onto BOWLSLINK in a timely manner.

It is hoped that by next year the BOWLSLINK will be able to create the Pennant Finals draws automatically from the Home and Away results, rather than having to manually create them.

At present Green information is not available for programming the draws, but it is a point that Savage Bull (BOWLSLINK creators) are working on. I expect that once the new draws are up, the Home club will be able to nominate which green will be used for the Pennant match when they enter their teams.

Once again, I advise that there are training notes and videos available for all members to view and use to access their own membership details and update them as required. There are many instances where the records are incomplete or incorrect. These can be corrected by the club's administrator or the members can adjust their own records. You can access the training videos from the Home page of the GVBD Website, or on the BV website at <a href="https://www.bowlsvic.org.au/clubassist/bowlslink/">https://www.bowlsvic.org.au/clubassist/bowlslink/</a>. The member registration notes are available on the GVBD Website under the Documents tab, titled STEP BY STEP GUIDE TO REGISTER WITH BOWLSLINK. (Note, you must have a valid email address registered with BOWLSLINK to do this. Your Club Administrator can input your email address if it is not yet entered or incorrect).

The more people that register and get a basic understanding of BOWLSLINK, the easier it will be for the Division (or Region) to manage in the future. Most clubs have no problems with managing the results for pennant, and there are facilities within BOWLSLINK for clubs to manage their own competitions. If the club administrator requires an assistant or wants to train their successor, they can request another administrator account directly from within BOWLSLINK. Click on the GREEN? mark in the lower right corner of the screen.

Clubs can get their own website at zero cost by contacting Matt Ottobre of BV, or Kelvin Rogers of Bowls Australia.
